1. BACKGROUND

A key priority for the Government is to close the gap in attainment between those from disadvantaged and non-disadvantaged background, and to ensure that every young person can fully participate in 16-19 education setting.

The Government has set aside some money for schools, colleges, training providers and local authorities to allocate to young people who need financial support to stay on in further education or training. This is called the 16-19 Bursary Fund.

The bursary allows students access to additional funds to support with: learning, participation in educational activities, transport, equipment and more.

There are two types of 16-19 Bursaries:

- **Vulnerable Bursary** For young people in one of the defined ESFA vulnerable groups.
- **Discretionary Bursary**Awarded by Finham Park Sixth Form to meet individual needs.

2. ELIGIBILITY

For students to be eligible for bursary funding, students must meet the age and residency criteria from the ESFA guidance 22-23 listed below:

- A student must be aged 16 or over but under 19 on 31 August 2022 to be eligible for help from the bursary fund in the 2022 to 2023 academic year or continuing on a course started aged 16 to 18 (19+ continuers).
- Meet the ESFA's residency criteria set out in the ESFA Funding Regulations 22-23.

3. BURSARY GROUPS

This policy provides students with the opportunity to benefit from the fund at different levels according to their individual circumstances. There are two groups at whom this policy is directed:

Bursary Group 1 – Vulnerable Student Bursary

The bursary for vulnerable groups can pay up to £1200 per year to a student enrolled in a full time course who is part of one of the defined ESFA "vulnerable groups". The defined vulnerable groups are students who are:

- in care -
- care leavers
- receiving Income Support (IS), or Universal Credit (UC) because they are financially supporting themselves or financially supporting themselves and someone who is dependent on them and living with them, such as a child or partner
- receiving Disability Living Allowance (DLA) or Personal Independence Payments (PIP) in their own right as well as Employment and Support Allowance (ESA) or UC in their own right.

Students experiencing financial hardship can apply for bursary funding. To be eligible for bursary funding, the student must currently qualify for Free School Meals (FSM). Confirmation of FSM status will be provided by Coventry City Council and updated on a weekly basis. More information on FSM, including how to apply, can be found at: <u>https://www.coventry.gov.uk/benefits-1/free-</u> school-meals/2

Bursary funding is extremely limited and funding is primarily directed to the above groups. Students experiencing financial hardship, that do not fit into the bursary groups above, can still make a request for funding. Decisions on whether funding will be provided will be made on a case by case basis by the Sixth Form team.

Bursary funding is spent at the discretion of Finham Park Sixth Form staff. The school is under no obligation to make payments from the bursary fund and can reserve the right to limit funding if standards of attendance and behaviour are not met.

Bursary funding is subject to change depending on the need and demographics of the student body. Finham Park Sixth Form cannot supplement the bursary once it's funds have been used up and no further student claims will be possible during that academic year.

4. APPLICATION PROCESS

All students will be made aware of the 16-19 Bursary and what qualifies them for bursary funding at the start of the academic year.

Students who are in receipt of FSM will not be required to provide evidence of income – subject to confirmation of FSM status by Coventry City Council. Students that qualify for FSM will be notified of their eligibility for bursary funding and invited to fill out the 16-19 Bursary Application Form. Any student that qualifies for FSM during the academic year will be signposted towards the 16-19 Bursary Application Form. The 16-19 Bursary Application Form must be returned to Finham Park Sixth Form before bursary funding can be spent.

5. PAYMENTS

Discretionary Bursary

All students qualifying for the discretionary bursary are deemed to have individual financial barriers to learning. To combat this, a basic curriculum materials/resource pack will be given to every qualifying student which will provide them with everything they need to succeed in their chosen courses. Any additional requests for bursary funding will be assessed on case by case basis by the Sixth Form Bursary Team. The Sixth Form Bursary team will process all funding requests internally and payments will be made "in-kind" rather than paying students directly. This is to ensure the correct use of the 16-19 bursary.

Students should make requests for additional funding in writing to the Sixth Form Bursary Team. An example list of items that students may receive bursary support for can be found below:

Vulnerable Bursary

The frequency and amounts of payments will be agreed between the student and the Sixth Form Bursary Team and will be made at regular intervals directly to the student's own bank account via BACS.

6. CONDITIONS OF BURSARY

Students must meet the following criteria in order to receive their bursaries:

- Have a target attendance of 95%. Authorised absences, such as illness, will be taken into account when reviewing attendance.
- Demonstrate good behaviour and adhere to Finham Park School values.
- Engage with teaching staff and complete work in time for agreed deadlines.

7. APPEALS

Any student who is dissatisfied with the decision made regarding the allocation of funds may appeal in writing to the Head of Sixth Form. The Head of Sixth Form reserves the right to authorise payments outside of these criteria where there are extenuating circumstances and/or there is clear educational value in releasing the funds.
